# **REPORTS BY COUNTY OFFICIALS:**

# -Clare County Commissioner, Jack Kleinhardt

- Several fact-finding meetings have taken place about the concerns with slower ambulance responses from MMR to parts of the county.

-MMR states that had 26,669 calls in Clare County in 2023, of that 5% were life and death situations.

-State Legislators are keeping the proposed bill alive-requiring septic tank inspection every 5 years.

-Several townships have been approached by companies wanting to start solar wind farms in the county.

# -Road Commissioner, Bill Simpson:

-Fisher Gravel came in with the same bid amount as they did in 2023.

-Super 6 Road Project is still ago for 2024/2025

-A new bridge will be installed on Colonville Rd between Eberhart and Brand Roads in 2026

-Gravel bill has stalled in Legislation

-Clare County Road Commission received feasibility study for new building for Road Commission. The current building is over 60 years old.

# **PUBLIC COMMENTS:**

Jeff Smith states that he has been working on the toilets at the township hall trying to get some of the lime build-up cleaned so that they are flushing better.
