REPORTS BY COUNTY OFFCIALS:

- Clare County Road Commissioner, Bill Simpson:
 - No new news out of Lansing
 - ➤ The tree cutting on Cornwell north of Mannsiding is nearly completed.
 - The tree cutting for widening of road and turn lane in front of new CTE building on S Clare Avenue has already started. Most work will start after Memorial Day.
 - ▶ 8 1/2 miles of paving road in Clare County has already been completed-5 miles in Winterfield Twsp, 2 Miles in Freeman Twp, 1 mile Frost/Franklin, ½ mile Redding twsp.
 - 2 bridges have already been done and reopened
 - Colonville Road bridge and work on the road will be completed by July 1.
 - Work has already started on the new Clare County Road Commission building has started. A shared driveway between CCRC and Cook's Forest Products, with a center divider.
 - Next MTA meeting is June 3 at 6:30 pm at the north end of Hayes Township Hall.
- Clare County Commissioner David Hoefling due to Jack Kleinhardt absence:
 - ➤ There have been several CC Sherriff office cars that have been wrecked/damaged in the past several months. The Clare County Commissioners approved \$34,000 for leases for new police cars.
 - ➤ The Clare County Commissioners approved to accept 2 grants for airport improvement totaling \$260,000. The airport officials have purchased used airport lighting from an airport in Romeo, MI. Crack sealing will also be done on the airport runways
 - A fly-in at Harrison Airport took place on May 17-the weather was not great so the turnout was low. Those that did attend seemed to enjoy themselves.
 - The airport property is owned by the County, but the hangers and restaurant lease the property and own the buildings.

- The Clare County Commissioners have adopted some new policies on how credit cards issued to county officials can be used.
- > The 5-year Covid policy has been repealed by the County.
- Bridge on the expressway near Bailey Lake Road was hit and was damaged
- Line painting has been happening in Greenwood and Redding Townships

 with township attorney, at the April 2025 meeting and agreed upon the appeal request,
 allowing August Hill to complete their contracts through the 2025 season and Special Use
 Permit would be ending with the Hatton Township in October 31, 2025. District Judge
 Ambrozaitis has not signed off on this case.

NEW BUSINESS

- Supervisor Hileman read a letter that the township received from FEMA wanting the township
 to complete a Flood Study-it was decided that the township does not have or has never had any
 flood issues.
- The township discussed and voted on the yearly Clare County Equalization Contract. Out of the 3 options, it was decided that the township would remain with option #3. It is more economical for the County to print and mail out the tax bills rather than the township completing the tasks. The yearly equalization contract for option #3 was \$1,293.00.
